The Coalition officially launched in late 2020, and the information below highlights its collective economic and community impact.

**Total Annual Revenue: \$681.8 million**



**74% Program Revenue**  
(including fee for service income and government grants and contracts)

**21% Contributed Revenue**  
(private donations from individuals, foundations, corporations, and bequests)

**6% Other Revenue**  
(investment and interest income, etc.)

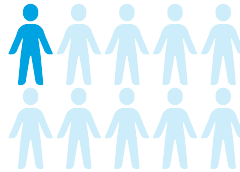

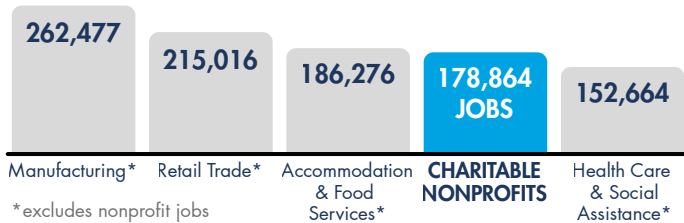
